#### WA 532 (Grantville)

- Daily presence of water truck- employed to manage both Granville and Glen Forbes; monitor conditions and change extraction and dust suppression management plan as required; Sweeper engaged weekly to manage public service rd.
- Natural seeding occurring no planting, natural brush matting used very successfully, Northeast face

#### WA 210 (The Gurdies)

- Campaign team moved to the Gurdies on the 11/11/2024 to begin one in three batter development and contour management Stage 2 of Rehabilitation.
- Earth works have now begun and will continue in stages over the next 2 years, expected "hand back" to "the power that be" late 2026

#### WA 970 (Glen Forbes)

- Trees monitored and pruned under continual management plan. Open grass areas managed by livestock with fence lines managed by contractor.
- Volume placed 23,300 cubic metres Location: Rehabilitation area E side of pit & Glen Forbes rd. and 100m off Western boundary
- Over 2000 indigenous trees planted in August 2024 by Landcare along southern boundary and gaps filled along the western boundary of WA970 and Bass hwy.

Halina asked regarding plans after handback of WA210; both Barry and Robbie explained hand back to His Majesty (in a better state) depends on what the original permit specifies- likely to remain under Park Victoria control.

Robbie also spoke further about the contractors they've got who translocate trees and address maintenance after said move-learning/ broadening their knowledge for greater success in this process.
