Traffic lights roadworks at entrance to commence after King Birthday Long Weekend and expected to take 4 months to complete; DTP reviewed and accepted Communications plan, including text and diagrams to be published as public notices (3 & 10th June) in SGST and PISRA, plus A4 letterbox Drop Pamphlet (notification to local residents, shops, businesses, Emergency Services, school and public transport operators; BCSC Asset Protection Officer has been notified via "Road Application Permit application; bottom line, taking trucks out of Grantville reduces risk to local population. Halina asked about signage approaching roadworks-Garry said ample warning addressing works ahead of actual works and good visibility on approach.

Barro

Work authority application suspended.

No further correspondence from BCSC regarding temporary road closure.

GSG

No actions required from recent inspections.

All requirements regarding dust, noise and weed control have been met; no community complaints.

Heidelberg

AAT (VCAT) set for 6/9/25 as Heidelberg pursue its legal right to operate under the planning permit; unfortunate that the possible loss of a handful of trees n Stanley Road could jeopardise the creation of a significant bio link which was to be created on Heidelberg land and link 82 hectares of remnant bushland in private ownership with the Grantville Fauna Reserve.

Anne Westwood stated the "Fire Management" conducted last week to protect residents was more destructive than Heidelberg's proposed plan.

Catherine Watson asked about the lifespan and truck movement projected; 5-6 years, 10 at most and 10-20 truck movements per day.

Sand Supplies/ Bass Sands/ Boral

As mentioned at (1) WA 532 (Grantville) and WA970 (Glen Forbes) assets sold to Boral; awaiting WA transfer (as of meeting date); impossible for small operators to survive the 14 years required to get quarries running to provide additional resources projected for 20 years time; Industry likely to contract to a few majors; 80 million tonne per year to replenish what is being used, 65 million



- Comprises six (6) representatives from the community and each Work Authority.
- Standing invitation to ERR, EPA and Bass Coast Shire Council (Ward Councilors and Officers)
- Provides a two way communication link between community and operators
- Valued Community Engagement information sharing & amenity feedback, facilitates local actions.

- Bass Coast Shire resource typically comprises a blend of fine, medium and coarse sands – not single sized, shaped – broad range of uses - contains one of the most important sources of construction sand in Victoria
- Thirteen (13) Work Authorities / quarry sites are currently located in Bass Coast Shire and underpin the +\$49 Billion Victorian construction industry
 - Three have long ceased operation and a fourth is a non-operating site with rehabilitation work only.
 - · Another site operates as Grantville landfill site
 - · A further three have a very limited time-life
 - Three of the remaining five sand quarries will remain active in the medium to long term.
 - The two other sites are yet to have Work Authorities issued by ERR to commence operations
- The GQRG is not aware of any future/proposed quarry applications in the Westernport Woodlands or Bass Coast Shire

Strategic Sand Resource

- Bass Coast Shire contains one of the most important sources of constructive sand in Victoria
- Grantville Sand Quarries provide local jobs and construction material for local Bass Coast projects.
- Sand quarries are fundamental to enabling the State and Local Government infrastructure projects.
- · Victoria's population is set to double by 2050.
- Victoria needs to build 2.3 million homes and upgrade its community infrastructure
- 2018 Joint Ministerial Statement on Extractive Resources
 - Need access to sand, rock and gravel to make affordable housing, roads and infrastructure
